**Subject: Selection Trial for the World Games 2025 – Chengdu, China**

Dear Sir/Madam

The Archery Association of India is pleased to announce the Closed Selection Trial for selecting the Indian Compound Archery Team for the World Games 2025, scheduled to be held in Chengdu, China.

The Selection Committee of the Archery Association of India has decided to conduct this trial from 25<sup>th</sup> to 28<sup>th</sup> May 2025 at SAI NCOE, Sonipat, Haryana. This decision was taken in view of the recent communication received from World Archery, which informed us that the final deadline for submission of names for the World Games is 2<sup>nd</sup> June 2025.

The trial will be held among the Top 8 Compound Men and Women Archers, identified based on their performances in the 1<sup>st</sup> Selection Trial held in Kolkata. The objective is to select 2 Senior Compound Men and 2 Senior Compound Women Archers who will represent India at the World Games 2025.

All participating archers and accompanying officials are required to make their own boarding and lodging arrangements. The Archery Association of India will provide ground facilities for the conduct of the trials.

The final team will be selected solely on the basis of performance in this trial.

**Selection Process for World Games**

**Eligibility**

Top 8 Archers from 1<sup>st</sup> Open Selection Trial 2025 – Kolkata, W.B.

**Selection Process**

**Event 1 – Qualification Round**

All Archers will be required to shoot another 6 x 50 M (Compound) @ 6 arrows in 180 sec.

Points shall be given to all 8 archers as undermentioned based on the cumulative score of the qualification round (6 x 50M).

Point system for the Cumulative scores of the Qualifications Round			
Rank	Points	Rank	Points
1	6	5	4
2	5.5	6	3.5
3	5	7	3
4	4.5	8	2.5

**Bonus Points:** Bonus points are additionally awarded to archers achieving the following benchmark scores in qualification rounds :

Bonus Points for Qualification Round		
Category	Benchmark Scores	Bonus Point
Recurve Men	690	0.25 per 2x70m/50m
Recurve Women	685	0.25 per 2x70m/50m
Compound Men	715	0.25 per 2x70m/50m
Compound Women	710	0.25 per 2x70m/50m

Note : Maximum Bonus **0.75 points** (if achieved in all three rounds). Bonus points will be awarded to the archers after completion of the Qualification Rounds i.e. 6 X 70M/50M.

**Event 2 – Round Robin (8 Archers)**

Qualified 8 Archers will be drawn to face each other in Round-Robin format to make the ranking of archers between 1 to 8. A win in each match gives an archer +1 point and a loss 0 point.

There shall also be Bonus Points to be given and Penalty points to be deducted for Event 2

The Bonus Points and Penalty Points for Event 2		
Category	Bonus Points	Penalty Points
Compound Men	0.25 bonus point for a core of 150 in a match	-0.25 penalty point for a score of 146 or less in a match
Compound Women	0.25 bonus point for a score of 149 and above in a match	-0.25 penalty point for a score of 145 or less in a match

To award the consistency for shooting high, the following additional points will be awarded based on the cumulative average score shot after all the matches. Archers shall be ranked based on the cumulative average scores and then points given. In case of a tie in average scores, both archers will get the same point.

Point system for Consistency scoring (Cumulative average)			
Rank	Points	Rank	Points
1	3	5	2
2	2.75	6	1.75
3	2.50	7	1.50
4	2.25	8	1.25

A combined points (match points, bonuses, arrow averages) finalizes the final rankings for Event 2. Based on the final ranking of the event, 2 archers will be awarded the following points:-

Point on Final Ranking of Event 2			
Rank	Points	Rank	Points
1	6	5	4
2	5.5	6	3.5
3	5	7	3
4	4.5	8	2.5

In case there is a tie for any positions after adding all the points of Event 2, one arrow shoot-off will be done to settle.

### Event 3 - Elimination Matches (8 Archers)

Elimination Round for Top 8 archers (1 vs 8, 5 vs 4, 3 vs 6 & 7 vs 2). Losers also play matches to rank 1<sup>st</sup> to 8<sup>th</sup> archers.

**Bonus & penalty points shall be added.** This ensures that archers can **focus on scores & winning matches**, The Point as per the final rank in elimination, shall be given as below

Point - Elimination Rank			
Rank	Points	Rank	Points

There shall also be Bonus Points to be given and Penalty points to be deducted for Event 3

The Bonus Points and Penalty Points for Event 3		
Category	Bonus Points	Penalty Points
Compound Men	0.25 bonus point for a core of 150 in a match	-0.25 penalty point for a score of 146 or less in a match
Compound Women	0.25 bonus point for a score of 149 and above in a match	-0.25 penalty point for a score of 145 or less in a match

The total points received by each Archer will be based on adding points achieved in the Elimination round & Bonus points & deducting the Penalty points.

### Final Ranking of the Selection Trial

The final ranking of the Archers will be decided after adding the final points earned by the Archers in Event 1 (including bonus points) + Event 2 + Event 3 (including bonus/penalties).

In case of a tie, the involved archers need to play a match to determine the winner. In case more than two archers are involved, they will face each other in a round robin format. If the tie cannot be resolved, a single arrow shoot-off shall determine the higher-ranked Archer.
