We are pleased to inform you that the Archery Association of India (AAI) is inviting applications from eligible and aspiring National Judges for the upcoming Continental Judges Seminar, scheduled to be held from 18th to 20th July, 2025 at The Emerald, The Leela Ambience Convention Hotel, Delhi.

This initiative is aimed at developing more Continental Judges within the country. Please note that a maximum of four (4) National Judges will be nominated by AAI for participation in the seminar.

### **I. Eligibility Criteria**

1. The applicant must be an experienced National Judge, (accredited on or before 2022) with a good knowledge of English.
2. The applicant must have officiated in the last three years in a minimum of five (5) national-level events, of which at least two (2) must be direct events of AAI (i.e., conducted and deputied by AAI).
3. In case AAI receives more than four eligible applications, the Judges Committee of AAI will conduct a selection exam at the AAI Office, DDA Yamuna Sports Complex, New Delhi, on 03<sup>rd</sup> June 2025.
  - o In the event of a tie in marks, preference will be given to the judge with more years of experience and a higher number of officiated events.

### **II. Application Submission**

Applications will be considered only if recommended by the President/Secretary of the respective Member State Association /Associate Member of the Archery Association of India.
