Eligibility conditions

- a) Please note that the accreditation status of all those candidates who successfully attended the 2024-PAN India Seminar-Hyderabad has been renewed as the National Judges up to 2027 (for three years). Similarly those candidates who successfully attended the 2023-PAN India Seminar-Amravati have been renewed as the National Judges up to 2026. Such successful candidates are exempted from attending the upcoming 2025-PAN India Workshop-Goa. However, if they wish to participate they can attend the Seminar so that they can renew their registration upto 2028. IJs, IJCs and CJs are also exempted.

- b) Those recognized by the Archery Association of India as National Judges in 2020 and onwards were asked to participate in the final 2024-PAN India Judges' Workshop-Hyderabad, but due to certain special circumstances, some of them could not participate. The upcoming PAN India Judges' Workshop-Goa will be the last opportunity for them to remain recognized as National Judges. If any such National Judge still fails to attend the Hyderabad-PAN India Workshop then they will have to attend the forthcoming Judges' Workshop in their respective zone to regain their status as National Judges.
- c) Those Judges recognized by AAI before 2020 and couldn't participate in last years PAN India Judges' Workshop-Hyderabad shall not be allowed to participate here. If they wish to remain as National Judge they have to attend the forthcoming Judges' Workshop in their respective zone
- d) The willing participant is required to submit an undertaking that he/she shall officiate at least one Competition/National Trial/Tournament in a year to be conducted by the Archery Association of India if assigned.

Language

The workshop will be conducted in English language only. In the last phase of the workshop, an examination will be conducted in the English language, and only those participants who qualify will be able to retain the status of AAI National Judge.

Registration Fee

- i) Rs.2,000/- (Rupees two thousand only) per head would be charged as a Registration Fee from each participant which is required to be transferred to the AAI bank account mentioned below –
