We would like to inform you that the Para assessment trial for the selection of the Indian Para Archery team which will represent the country in the Para Archery – World Ranking Tournament – Czech Republic & World Para Archery Championships – Korea will be held at DDA Yamuna Sports Complex, Delhi on 15th & 16th July, 2025. The detailed schedule is given below:

Arrival	Competition Days	Departure
14 th July, 2025	15 th & 16 th July, 2025 (07:30 am onwards)	17 th July, 2025

All para-archers with a valid classification certificate issued by World Archery or the Archery Association of India are eligible to participate in this trial.

All participating archers and accompanying officials must make their own arrangements for boarding and lodging. The Archery Association of India will provide ground facilities for the trials. Lunch at the competition field and other logistical/hospitality facilities will be provided, subject to approval from the competent authority.

All entries should come through Member State Associations/Associate Members. No individual entries shall be entertained. All State Associations/Associate Members are required to send their entries through 'Tournament Manager' only on or before **5th July, 2025**. No entries after the deadline will be accepted.

1. Eligibility

All para-archers with a valid classification certificate issued by World Archery or the Archery Association of India are allowed to participate in the Para Assessment Trial.

2. Date & Schedule

15th July, 2025– Qualification Rounds
16th July, 2025 – Elimination Rounds

3. Venue

DDA Yamuna Sports Complex, Delhi

4. Selection Process

4.1 Qualification Round : All eligible Archers will shoot 4 x 70m Recurve, 4 X 50m for Compound & 4 X 50m for W1. The top 8 archers or lower, based on the cumulative points of the 4 x 70m/4 x 50m shall play two rounds of elimination matches.

Points shall be given to the top 8 archers as undermentioned, based on the cumulative score of the qualification round of 4 x 70 M/4 x 50 M.

Point system for the Cumulative scores of the Qualifications Round			
Rank	Points	Rank	Points
1	4	5	2
2	3.5	6	1.5
3	3	7	1
4	2.5	8	0.5

In case of a tie for any position, a single arrow shoot will determine the winner.

4.2 Elimination Round - @ 2 Elimination Round for Top 8 archers. Losers also play matches to rank 1st to 8th archers. In case there are fewer than 8 archers, then the top archer gets a bye.

4.2.1 1st Elimination round bracket will be drawn based on the ranking of archers in the Qualification round.

4.2.2 2nd Elimination round bracket will be drawn based on the ranking of archers in the 1st elimination round

The following points shall be given to the archers after each of the elimination rounds :

To award consistency for shooting high during the elimination rounds, the following Bonus Points will be awarded

5. Final selection of the Team

- The Team will be selected based on the total cumulative points earned by the archers – Qualification Round points + 2 Rounds of Elimination Round points + consistency average points.
- In case of a tie for any position, a single arrow shoot will determine the winner.
- The selection committee will make the final decision on the selection of archers, subject to the verification of the Minimum qualification of Archers.

The selection committee reserves all the rights to make any changes/amendments if required
