Subject: 2nd Assessment Trial for the 2026 Para Asian Games (Aichi-Nagoya) & 2026 World Archery Para Series. Revised Notice — Revised Notice

Dear Sir/Madam,

With reference to the Archery Association of India circular dated 15th April 2026 on the subject cited above, this is to inform you that the Selection Committee, at its meeting held on 22nd April 2026, reviewed the updated APC Qualification Criteria (Version 4.0) and resolved that only those archers shortlisted in the 1st Phase Trial who have achieved the prescribed Minimum Qualification Standard (MQS) at a World Ranking Event between 30th March 2025 and 9th April 2026 shall be eligible to participate in the 2nd Assessment Trial.

In the W1 Women category, since only one archer has achieved the required MQS within the qualification period, India is eligible to obtain only one (1) quota place in this category. Accordingly, the Selection Committee has decided that no Selection Trial shall be conducted for W1 Women. The eligible archer shall participate directly in all relevant events leading to the Asian Para Games.

As per the above, the number of archers in each category is as follows: RMO – 4, RWO – 5, CMO – 4, CWO – 5, W1M – 3, and W1W – 1. The names of the archers shortlisted in each category are listed below:-
