**Subject: Update Regarding Entry Restrictions for NTPC Cherukuri Lenin Volga Memorial National Archery Championship 2025.**

Dear Sir/Madam,

We are writing to inform you about an important update regarding the 14<sup>th</sup> NTPC Cherukuri Lenin Volga Memorial Mini (Under-15), 1<sup>st</sup> NTPC Cherukuri Lenin Volga Memorial Kids Under-13, and 6<sup>th</sup> NTPC Cherukuri Lenin Volga Memorial Kids Under-10 (Open) National Archery Championship, which will be held at Guntur, Andhra Pradesh from 20<sup>th</sup> to 29<sup>th</sup> March 2025. This event is being organized under the aegis of the Andhra Pradesh Archery Association.

Under the AAI notification issued earlier, the entries for the Under-10 and Under-13 categories were kept open on the AAI portal. However, the organizers have requested AAI to restrict the entries in each category. The details for the categories are as follows:

If the number of entries in Recurve or Compound or Indian Round categories is not fully utilized in one gender, the remaining entries can be compensated in the respective opposite gender category, but the total for each category should not exceed 20 entries. For example, if there are 6 entries in Recurve Women, the remaining 4 entries can be adjusted in Recurve Men. In such cases, for any additions or subtractions to the entries, a proper intimation must be given to AAI through an email:indian.archery@yahoo.in. Only then can we consider the changes.

We request all state associations to review the entries submitted on the AAI portal. In case your state has entered more than 10 archers per category, please ensure to remove the extra entries immediately. If this is not done, only the first 10 archers per category will be selected based on the serial number of the entries as listed on the AAI portal.

We appreciate your understanding and cooperation in ensuring that the entries are properly adjusted in line with the revised entry limits.

Thank you for your prompt action in this regard.
